1. Choice of scrutineers

2. Approval of the Agenda, selection of scrutineers

The agenda is unanimously adopted.

3. Minutes of 2021 General Assembly

The minutes of the 2021 General Assembly are unanimously approved.

4. President's Address

Ellen Hertz welcomes the participants to this General Assembly, which can finally be held in person again after two online editions. She gives a brief overview of the present situation of the SAA and current issues treated:

- Recently, currents events in the world raised the question whether the Association should officially take a stand (e.g. on the Russian war on Ukraine, Black Lives Matter) and publish a position paper. The Board has discussed this question a number of times, and in the past, the SAA has done so on certain occasions (for example on immigration issues or on research ethics). From EH's point of view, this only makes sense when anthropology has

something specific to say or to add to the ongoing public discussion. In addition, the elaboration of a position paper is a lengthy and laborious process, and therefore the Board often hesitates to take an official position.

Of course the SAA Board is considering the best ways to communicate with its audiences to make anthropology more visible. Hence, the Board encourages membership to publish blog posts, petitions, news of current issues etc. in the news section of the SAA website, by sending these to our webmistress, Miriam Wohlgemuth (webmaster@seg-sse.ch). This information will also be transmitted through the SAA monthly newsletter.

- It is a pleasure to see that how much energy the membership, especially students, doctoral students and post-docs, put into the SAA and it is only with their contributions that the hosting institutions in Neuchâtel put together the wonderful program of the 2022 edition of the Annual Meetings, which will open right after the General Assembly. They deserve our warmest thanks for that.
- The Board also welcomes Students and *Mittelbau/Corps intermédiaire* to propose to discuss questions that interest young scholars, such as co-creation, different forms of collaboration, alternative restitution.

These are the issues that the SAA is or has been working on:

- The *Position Paper on "Open Science and Data Management in Anthropological Research"*, aimed at the Swiss anthropological community, is the result of a four-year, multi-party process catalyzed by new data management protocols instituted by the Swiss National Science Foundation.
- "*Executive Summary*" of the Position Paper which provides a synthesis of the Position Paper specifically aimed at the principal institutions governing research in Switzerland.

- Risk in the Field, an issue that the GRED (Groupe de Réflexion Éthique et Déontologique) is presently working on.
- The situation of precarity for young scholars (non-tenured teachers and researchers in academia). Ellen Hertz suggests that a group of concerned members pursue this issue now that this has been discussed in parliament.

Ellen Hertz also informs the Assembly that the SAGW will finance a small four-year secretariat position to promote a social science book series called "Penser la Suisse" published by Seismo, (see <https://www.seismoverlag.ch/en/books/reihen/penser-la-suisse/>). The series is aimed at journalists and politicians, or people who are interested in the results of social science research for policy purposes. Penser la Suisse (PLS) seeks looking for authors who will write concisely on current issues, based on empirical anthropological research. PLS will request that the SAA and other concerned learned societies contribute to paying for this secretariat position when the SAGW's four-year seed money runs out.

5. Accounts and balance sheet 2021, auditor's report

Christiane Girardin, SAA secretary, presents the accounts and balance for the year 2021 (cf. annex 1):

After a year that was heavily impacted by the onset of the pandemic, 2021 was a relatively good year. The meetings and colloquia were organized almost as usual, except for the Annual Meeting, which had to be held online. The accounts closed with a moderate surplus (CHF 9'669.43) at the end of 2021, which can be explained in part by higher membership fees for the well-to-do as decided in 2019, and also by keeping the expenses for the administration (secretariat), Tsantsa and the website within reasonable limits. This allows the SAA to gradually rebuild at least some reserves for unexpected expenditures.

The accounts for 2021 have been duly audited by Virginia Suter Reich and Claude Grin who present their auditors' report stating that the audit they carried out jointly went well and that the profits and losses statement and balance sheet are in accordance with the accounts.

The GA unanimously approves the 2021 accounts with no abstentions and discharges the Board.

6. Budget for 2022 (final), budget for 2023 (provisional)

Budget 2022 (cf. annex 2): Christiane Girardin presents the final version (last year we presented the provisional version as we did not yet have the final figures from the SAGW/ASSH).

Provisional budget 2023 (cf. annex 3):

On the right column, there is a preview of the SAGW/ASSH subsidies, but these figures are still provisional. The Academy will communicate the final figures in February 2023.

Overview of the figures of SAGW/ASSH subsidies for 2021-2023 (cf. annex 4).

Compared to 2021-2022, in 2023 there are very few requests for meetings and colloquia because there are still subsidies for 2021 that have been kept on hold with the SAGW because of the pandemic. The budget for 2023 is still provisional because SAGW cannot communicate the final figures for 2023 before mid-February of 2023.

7. a) Reports of the commissions and working groups

i. Audio-Visual Commission (CAV)

Baptiste Aubert and Saada Elabed, the co-presidents of CAV, give a summary of the concerns and activities of the commission in 2022:

- They organized, together with Laura Coppens, a Summer School in Visual Anthropology "Beyond Observational Cinema" that took place in St. Blaise on September 12-17, 2022 and had 11 participants.
- CAV organized a Session at the Regard Bleu Film Festival (<https://regardbleu.ch>) in Zurich where the films produced during the above Summer School were screened.
- CAV is continuing to develop a project that will allow the SAA to stock digital films on a server and make them available to members. For this purpose, the CAV stopped

buying new films for the collection and plans to ask the SAGW to repurpose these funds for digital infrastructure.

ii. Editorial Commission

Filipe Calvão, member of the Editorial Board, informs the Assembly that the Editorial Commission that, in addition to the usual work of preparing the next issues, the Commission has been working on the name change from *Tsantsa* to *Swiss Journal of Sociocultural Anthropology (SJSCA)*. This work includes developing the new logo and graphism for the cover of the journal as well as implementing XML for all the issues, which will allow all the citations to be indexed and counted by citation indexes like Social Sciences Citation Index (SSCI), and applying double-blind peer reviewing to all the articles of the journal.

The special online-only issue of *Tsantsa*, vol. 27/2022 with guest editors Peter Larsen, Doris Bacalzo, Mò Bleeker, Patrick Naef, Eda Elif Tibet, Baracchini and Susie Riva on *Engaged Anthropology in and beyond Switzerland*, was published in April 2022. The regular print-and-online vol. 28/2022 with guest editor Frédérique Leresche on *Anthropological knowledge and power relations* will be published shortly. This issue will be the first to be published under the new name of *Swiss Journal of Sociocultural Anthropology (SJSCA)*. SJSCA 29/2023 is entitled: *The law of the outlaw: Law and order in, with, and beyond criminal groups* and is already in preparation.

iii. Ethical and Deontological Think Tank (EDTT/GRED)

Anne Lavanchy and Wiebke Wiesigel, the two new co-coordinators of the Working Group EDDT/GRED, inform the Assembly that, after many years working on questions of research ethics, the context has changed; the EDTT/GRED will now function as a platform for discussion on fieldwork and has merged with the Working Group "Risk in the Field". In the context of fieldwork, ethics is not only about protecting the anthropologists' research partners, but also about the anthropologists protecting themselves and the researchers they supervise.

The GRED has co-organized a panel on *Reciprocal Vulnerability: Privilege, violence, and practices of care from fieldwork to academia* at the Annual Meetings.

iv. Interface Commission

Doris Bacalzo is replacing the president of the Interface Commission, Peter Larsen, who cannot attend the General Assembly, and gives the report for the year 2022.

During the COVID period, the Commission essentially met on Zoom. In 2022, the Interface Commission organized a colloquium entitled "Imagining new anthropological futures" that was postponed from 2021 and took place from September 17-18, 2022 in Ascona. It has also organized a round table discussion on "Pasts and Futures in Swiss Engaged Anthropology" to be held at this year's Annual Meeting in Neuchâtel.

The Commission co-edited the Tsantsa online-only special issue of *Tsantsa*, vol. 27/2022, entitled *Engaged Anthropology in and beyond Switzerland*, and published in April 2022.

The Commission also had on-line "Conversations" at lunch time where people could present their work.

One of the main scopes of the Commission is to come together to understand what is engaged anthropology today, and to figure out how to create an interface between research, teaching, and participating students around how anthropologists can be more reflexive about the work they are doing.

v. *Medical Anthropology Switzerland – MAS*

As the president of MAS, Eva Soom Ammann, cannot be present, Ellen Hertz gives a brief summary of annual report of the MAS for 2022:

MAS accepted the invitation to be a non-financing partner in the 'antenne suisse' conference of AMADES on "Covid-19 through the lens of social sciences" held at the CHUV in Lausanne on June 3, 2022 (cf. <https://amades.hypotheses.org/14309>). This event, organized by Rose-Anna Foley, Nolwenn Bühler, Julie Castro and Nils Gruber, involving MAS-members as speakers and chairs, was a parallel event to others in French-speaking countries.

The following MAS events have been/will be held in autumn 2022:

- MAS Symposium "Exploring Expertise", convened by Julia Rehsmann and Eva Soom Ammann (Bern University of Applied Sciences) was held fully on site on 20-21 October 2022, at Bern University of Applied Sciences.
- MAS Symposium "The Datafication of Health: Reconfigurations of skills, expertise, and knowledge", convened by Giada Danesi (University of St. Gallen), Sandra Bärnreuther (University of Lucerne), Nolwenn Bühler (STS Lab/UNIL), in collaboration with Tanja Schneider (University of St. Gallen), to be held as a hybrid event on November 10-11, 2022, at the University of St. Gallen.

The following MAS events, which had to be postponed several times due to the pandemic, will be held in 2023:

- MAS Symposium "Health. Care. Gender.", convened by Sonja Merten (Swiss TPH) and Sandra Staudacher (University of Basel), in collaboration with Joëlle Schwarz (Unisanté).
- MAS Seminar "Cultural Competence Applied: (Re)shaping Clinical Pathways", convened by Sylvie Schuster (Insel University Hospital Bern), in collaboration with AG Medical Anthropology der Deutschen Gesellschaft für Völkerkunde.

vi. *Museums Commission*

Mareile Flitsch, president of the Commission since 2021, informs the Assembly that she tried to relaunch it as a platform for discussion where all ethnography museums are represented. She organized an online round table on the consequences of COVID for the Museums at the last Annual Meeting which was very interesting because all the museums

have been hit very hard under COVID, economically and in many other respects. Now museums are very busy relaunching and dealing with issues of decolonization.

The Commission has organized a panel at the upcoming Annual Meetings in Neuchâtel entitled “Beyond the innocent museum: Swiss ethnographic museums in exchange with source communities”. The Commission will also ask the editors of SJSCA whether they would be interested in publishing a special issue on this topic.

Furthermore, the Commission is preparing for 2023 a colloquium entitled “Enduring Colonialism”, or “Critical Museum Approaches”.

The Commission will also tackle the issue of digitizing museum collections.

vii. Working Group ‘Anthropology and Education’

Angela Stienen, co-ordinator of the Working Group ‘Anthropology and Education’, which comprises around 20 active members, informs the Assembly that this year was mostly devoted to introspection, because some members of this Working Group who work at Universities of Teacher Education were very much engaged in curriculum reforms and making anthropology more prominent in the curriculum.

The Working Group decide not to organize a panel, but an open workshop on “Sharing ethnographic knowledge in the field of education: irritations and relational dilemmas” at the upcoming Annual Meetings in Neuchâtel.

The Working Group gained new members, and after a time of reflection in 2022, it will be more visibly active again in 2023.

b) Transformation of the Working Groups Anthropology and Education and GRED/EDTT into commissions according to Art. 15b of the statutes

Ellen Hertz explains to the Assembly that since the Scientific Commission, of which the working groups depend, has been dormant since 2019, the Board has decided that the remaining working groups, Anthropology and Education and GRED/EDTT, which have both been very active for many years, should be transformed into commissions under Art. 15b of the statutes. This decision is warmly applauded.

8. Information on the Annual Meeting 2022, outlook on 2023/23

Ellen Hertz informs the Assembly that everything is ready for the Annual Meeting 2022 “Give and Take. Anthropology as exchange” (Neuchâtel, Nov. 10-11, 2022) which will open immediately after this General Assembly. The organizers expect 138 participants, which is almost too many for the venue.

The next issues will be in June 2024 in Lucerne (no Annual Meeting in 2023), and then in Fribourg in the fall of 2025.





9. Admission of new members, resignations and cancellations of memberships

Presentation of the number of members (472, before admission of new members) following resignations (15), deaths (1), exclusions for non-payment of membership fees (30) as well as the new admissions for 2021 (14). (cf. annex 5)

All the members who applied for membership after the 2021 GA and paid their fee for 2022 (31) are admitted unanimously with no objections; this brings the number of members to 503 as of November 10, 2022.
